YEAR IN REVIEW

Finally, in 2022 we returned to campus and in-person meetings and events. By coincidence, our first in-person gathering was the Graduate Student Conference, which was also our very last event prior to the COVID pandemic. After almost two years of zoom meetings, the sheer joy of being together again, of discussing, listening, and learning was palpable. It has not diminished. But we have not forgotten our online friends in faraway places, and continue to offer many events in hybrid format or as video recordings.

During 2022, which marked our 15th anniversary, we hosted 38 events attended by over 2600 people, in-person and online. The early part of the year was dominated by Russia's invasion of Ukraine. I was particularly touched by our conversation with Ukraine's former ambassador to Canada. We marked Black History Month with a fascinating talk by Howard French, author of *Born in Blackness*. All told, we welcomed scholars from over a dozen countries, including Australia, Côte d'Ivoire, France, Haiti, Scotland, Wales, and the US.

CIPS research activities continue to flourish. We held an international workshop on the African Union's 20th anniversary, and a forthcoming Special Issue of *Global Studies Quarterly* will explore the AU and Pan-Africanism's role in global politics. The Global Right project met for an intensive writing workshop; stay tuned for the forthcoming book! We received two MINDS grants from the Department of National Defence: one investigating AUKUS and the other the humanitarian-peace-development nexus in the Democratic Republic of the Congo. We also released a much-discussed report on the future of the Canadian foreign service.

The CIPS Blog continues to thrive, sparking debate about key issues in international politics and Canada's place in the world. Our most talked about and read blogs are those that deal directly with Canadian issues, but we also strive to cover topics that are often overlooked and to offer a different, expert perspective on current affairs.

This is my last Year in Review-letter. After six years as Director, I will be stepping down in June 2023. It has been a privilege and a pleasure to work with so many smart, talented people. My sincere thanks to everyone who has helped make the past years such a success – our research networks, the University of Ottawa, and our many partners and collaborators. Thanks also to our audiences – in Ottawa, Canada, and beyond. Please continue to come back! I look forward to joining you in the audience.
